1. **Welcome & Introductions.**
2. **Approval of minutes.** The work group will be asked to review and approve the meeting minutes form October 9, 2007
3. **Review and discuss the draft Control and Management Charter Objectives.** Principal discussions will focus on review of the draft Control and Management work group Charter Objectives 1 through 3, focusing on development of recommendations for the draft management plan and implementation plan. The group may discuss all or a prioritized set or parts of the objectives outlined in the draft Control and Management Charter. 4. **Identify and discuss past agency responses that dealt with invasive species.** Principal discussions will be focused on past incidences that have required a state agencies response to a critical situation that involved an invasive species. Outline how these past responses might be incorporated into recommendations found in the charter.
5. **Assign work group action items and review future Control & Management Work Session dates, times and locations.**
