- 3) **Reading of Letter from Governor Janice K. Brewer** ~ Vice-Chair Michael Coles
- Governor unable to stop by meeting today so provided letter of her appreciation for their service on this council and her ongoing support for small business owners in the State.

4) **Arizona Department of Commerce Update** ~ Jerry Ewing, Deputy Director

- a. Commerce focused on *Economic Development | Attraction | Retention | Growth*
- b. Commerce has lots in common with and is sharing some of the same experiences as small businesses out there right now:
  - ✓ Economy is still not “good”
  - ✓ Agency reorganization in June – agency went from 7 divisions to 5 — downsizing
  - ✓ Another 15% across the board cuts to be submitted as of 10/9/09 — more cuts
  - ✓ Expenses up -- revenues down — still trying to make ends meet
- c. Kathy Rodriguez is a great resource to Commerce and the Council; Commerce is here to assist
- d. Provided background on new Commerce Director, Don Cardon, appointed by Governor in June ‘09
  - 1. Very strong business, finance & economic development background
  - 2. Director Cardon is the policy advisor to the Governor on economic development in the state

- a. *“The Not So Attractive Recovery” (But it has great personality!)*
