### 53<sup>rd</sup> Legislature – 2<sup>nd</sup> Regular Session adjourned sine die Friday, May 4 at 12:26 a.m.

On **Day 116**, last day of the session, **1,206 bills posted**; **369 passed**; **285 signed**; **16 vetoed**; **122 Memorials or Resolutions posted**; **28 passed**. (Arizona Capitol Times) Following adjournment, the Governor has 10 days to sign or allow a bill to become law without a signature.
