# Recap of 53<sup>rd</sup> Legislature – 2<sup>nd</sup> Regular Session

116 days of the session, 1,206 bills posted; 369 passed; 346 signed; 23 vetoed; 122 Memorials or Resolutions posted; 28 passed. (Arizona Capitol Times)

### Tracked bills signed by the Governor

**HB2042:** insurance coverage; telemedicine; urology – includes urology as part of health care services beginning January 1, 2020; pain medicine and substance abuse as of January 1, 2019

**HB2124: life & disability insurance; insolvencies** – relating to Life and Disability Insurance Guaranty Fund - House **Summary** 

**HB2149:** pharmacies; remote dispensing – includes a remote dispensing site pharmacy where a pharmacy technician or pharmacy intern prepares, compounds or dispenses prescription medications under remote supervision by a pharmacist - Chaptered <u>Version</u>

**HB2168:** mobile homes; recreational vehicles; fund – includes an increase for eligible tenant - actual moving expenses of relocating the mobile home increases from five to seven thousand five hundred dollars or from ten to twelve thousand five hundred dollars for a multisection

**HB2191:** military families; assistance; subaccounts – relating to the Military Family Relief Fund - House <u>Summary</u>

**HB2197:** health professional; workforce data – adopts rules prescribing the designated database information to be collected by health professional regulatory boards for the health professionals workforce data base - Chaptered <u>Version</u>

**HB2235: dental therapy; licensure** – creates new dental provider, includes in relevant Board statutes and permits dental therapist to practice under the direct supervision of a dentist or pursuant to an Agreement for services - Chaptered <u>Version</u>

**HB2256:** podiatrists; examination; repeal – Chaptered <u>Version</u>

**HB2317: disability plates; permanent placards** – eliminates the renewal process for a permanent disability removable windshield placard - Chaptered <u>Version</u>

**HB2324: community health workers; voluntary certification** – defines certified community health worker; outlines role of Director of Department of Health Services, application process for certificate, certification renewal, reasons for suspension, revocation of certificate, disciplinary action, appeal, investigations, fees and what the article does not include - Chaptered **Version** 

**HB2529: assisted living; referrals; disclosure** – includes requirements of referral agency to prospective resident or representative of resident at the time or before any referral is made for care at an assisted living facility – Chaptered <u>Version</u>

**HB2549: controlled substances; dosage limits** – relating to prescriptions and dosage limitations – House **Summary** Chaptered

**HB2575: license; nonoperating identification; homeless veterans** – relating to homeless veteran identification license – House **Summary** Chaptered

**HB2588: service animals; misrepresentation** – relating to service animal misrepresentation – House **Summary** Chaptered

**HB2656: electronic wills and trusts** – includes requirements for electronic wills, exclusions and requirements for qualified custodians - House **Summary** Chaptered

**SB1034: sunrise process; committee of reference** – relating to committee of reference membership and sunrise process for health professionals - Chaptered <u>Version</u>

SB1089: purple heart day – Chaptered Version

SB1162: silver alert notification; developmental disabilities – expands silver alert to include

a missing person who has a developmental disability - Chaptered Version

**SB1204: trusts and estates** – relating to probate proceedings and trust instruments - Chaptered **Version** 

**SB1218: developmental homes; licensure; investigations** – relating to adult and child developmental home licensure – House **Summary** Chaptered

**SB1245: appropriation; snap; benefit match; produce** – relating to appropriations and DES - Chaptered <u>Version</u>

**SB1287: ADOT revisions** – relating to ADOT electronic procedures and expansion of allowable provisions for Director - House **Summary** Chaptered

**SB1296: government communications; emergency response interpreters** – includes requirements of state, cities, towns and counties - House **Summary** Chaptered

**SB1451:** patient referral inducements; prohibited compensation – prohibits person, health care provider, health care facility or sober living home, only when providing or offering substance use disorder services in exchange for any form of compensation, in return for either: referring patients or clients to or from a sober living home or substance use disorder treatment facility; accepting or acknowledging the enrollment of a patient or client for substance use disorder services at a sober living home

**SB1504: developmental disabilities rates; appropriations** – requires the Legislature to annually adjust the appropriations made in the previous fiscal year to DES to provide DD services for persons whose service costs exceed the current cost-effective study rate; appropriates \$1.1 M from the Special Administration Fund in FY 2019 to DES to provide DD services for persons whose service costs exceed the current cost-effective study rates

#### **Budget**

DHS – One-time Alzheimer's Research funding - \$2 million

AHCCCS – skilled nursing provider rate increase - \$2.7 million

DES – one-time food bank - \$1 million

DES – skilled nursing 3% rate increase (DD) - \$174,200

DES - \$471,000 for aging services

DES – replaced one-time funding from FY2018 with federal support and expands the program (APS) by adding hotline and field staff to fully fund caseload growth demands.

#### FEDERAL OVERVIEW

From the **Social Security Administration** – On June 5, the Social Security Board of Trustees released its annual report on the current and projected financial status of the Old-Age and Survivors Insurance and Disability Insurance (OASDI) Trust Funds. The combined funds are projected to become depleted in 2034, the same as last year, with 79 percent of benefits payable after that time. The DI Trust Fund will become depleted in 2032, extended from last year's estimate of 2028, with 96 percent of benefits still payable. \*S.324 State Veterans Home Adult Day Health Care Improvement Act of 2017 Introduced on 2/27/2017 by Senator Orrin G. Hatch Enrolled text HERE

Introduced on 2/5/2018 by Senator Johnny Isakson (GA)

To establish a permanent community care program for veterans, to establish a commission for the purpose of making recommendations regarding the modernization or realignment of facilities of the Veterans Health Administration, to improve construction of the Department of Veterans Affairs, to make certain improvements in the laws administered by the Secretary of Veteran Affairs relating to the home loan program of the Department of Veterans Affairs, and for other purposes.

# \*S.2155 Economic Growth, Regulatory Relief, and Consumer Protection Act

Introduced on 11/16/2017 by Senator Mike Capo

Title III – Protections for veterans, consumers, and homeowners

The bill allows financial institutions and third-party entities to offer training related to the suspected financial exploitation of a senior citizen to specified employees. The bill provides guidance regarding the content, timing, and record-maintenance requirements of such training.

# S.2888 Geriatrics Workforce Improvement Act

Introduced on 5/21/2018 by Senator Susan M. Collins (ME)

To amend Title VII of the Public Health Service Act to reauthorize programs that support interprofessional geriatric education, training, and advance research to develop a geriatric-capable workforce, improving health outcomes for a growing and diverse aging American population and their families, and for other purposes.

5/21/2018 Read twice and referred to the Committee on Health, Education, Labor, and Pensions.

# H.R.5912 To amend title XIX of the Social Security Act to delay the reduction in Federal

medical assistance percentage for Medicaid personal care services and home health services furnished without an electronic visit verification system, and for other purposes.

Introduced on 5/22/2018 by Representative James R. Langevin (RI-2)

5/22/2018 Referred to the House Committee on Energy and Commerce

# H.R.5684 Protecting Seniors From Opioid Abuse Act

Introduced on 5/7/2018 by Representative Mike Kelly (PA-3)

This bill establishes individuals who are identified as at-risk beneficiaries for prescription drug abuse as qualifying participants in medication therapy management programs under the Medicare prescription drug benefit.

5/9/2018 Ordered to be Reported by Voice Vote

#### **H.R.5676 SENIOR Communities Protection Act**

Introduced on 5/3/2018 by Representative Thomas MacArthur (NJ-3)

The bill authorizes the suspension of payment to a pharmacy under the Medicare prescription drug benefit and Medicare Advantage prescription drug plans pending the investigation of a credible allegation of fraud by the pharmacy. A fraud hotline tip, without other evidence, may be considered a credible allegation of fraud.

# **H.R.5477 Rural DOCS Act**

Introduced on 5/17/2018 by Representative Tom O'Halleran (AZ-1)

The bill requires the Centers for Medicare and Medicaid Services (CMS) to carry out a demonstration project to provide an enhanced federal matching rate for state Medicaid expenditures related to the expansion of substance-use treatment and recovery services. 5/17/2018 Ordered to be Reported (Amended) by Voice Vote.


