Adding Jobs

Between December 2014 and February 2020, Arizona added more than **380,000 new jobs**. Arizona Office of Economic Opportunity

Booming Population

Between 2015 and 2020, Arizona added **536,336 residents**. That's **nearly 300 people a day** (293 to be exact). Arizona Office of Economic Opportunity

According to the most recent census estimates, Arizona is the **second-fastest growing state** in the nation.

Net-migration: Phoenix is the **#1 for net migration**. U.S. Census Bureau

A recent study ranks the Phoenix Metro area **number one** for attracting and retaining high-quality workers.

Under Governor Ducey's leadership, Phoenix became the **5th largest city** in the nation, 2017. U.S. Census Bureau

Arizona is **adding homeowners faster than any state in the nation**, a sign of continued growing economic momentum in the state. The state's homeowner rate increased from **64% to 71.7% (7.7%)** from Q12020 to Q22020 – **the fastest growth in the nation**.





Growing Businesses

Since Fiscal Year 2015, the Arizona Commerce Authority has won more than **720 competitive projects** with business **expanding or relocating** to the state.

In 2020, Arizona was ranked **#3 in the nation for Economic Momentum** by State Policy Reports, which takes into account measures of personal income, employment, and population growth. *State Policy Reports*

Since 2015, Arizona has added more than **18,000 new businesses.** Arizona Commerce Authority








Increasing Income

With a **personal income growth rate of 8.4%**, Arizona's personal income rose last year at a **rate faster than nearly any state in the country.** Bureau of Economic Analysis

Since 2015, household income has **increased more than 17%**, from **\$52,000 to \$62,000.** American Community Survey





Reducing Poverty

Approximately **175,000 Arizonans pulled themselves out of poverty** between 2015 and 2018. During that time, Arizona's poverty rate decreased by 3.4 percentage points – the largest percentage point reduction of any state in the nation. *American Community Survey*



Growing Manufacturing Jobs

Arizona added more than **17,000 manufacturing jobs** between January 2015 and February 2020. Arizona Commerce Authority

During 2019, Arizona saw stronger manufacturing growth than we've seen at any time in the past 30 years. Currently, there are **177,600 manufacturing jobs in Arizona**. That's more than the national average of 167,000 and more than the number of Arizona construction jobs which sits at 169,000. *Emsi 2020.4*

Throughout the COVID-19 pandemic, Governor Doug Ducey has taken a measured, pragmatic approach to keep Arizonans safe and healthy, while providing economic stability for essential services such as manufacturing and construction. As a result, the Phoenix metro area was the **only top 10 U.S. metro area to show an increase in various construction starts**, equating to **\$2.8 billion** in projects during the first half of 2020 compared to 2019.

Credit Upgrade

In 2019, the credit rating company Moody's Investors Service announced it is upgrading Arizona's credit rating from **Aa2 to Aa1**, the second-highest rating Moody's offers. Arizona is also the only state to have received **two ratings upgrades** from Moody's in the past six years.







Record Exports

Arizona ranked **sixth in the nation** for exports percent increase from 2018 to 2019. U.S. Census Bureau

Since 2015, Arizona exports have increased by 10%, reaching a **record high 24.7 billion**. U.S. Census Bureau





North American Trade

Arizona was a champion and advocate for the United States-Mexico-Canada Agreement (USMCA), which was ratified and signed in January 2020.

More than **228,000 jobs** in Arizona are dependent on trade and investment with Mexico and Canada.

Northbound truck crossings have **increased in 2020 by over 34,000 trucks**, or 8.9%, since 2015. This is a record for the total number of commercial trucks that crossed the Arizona-Mexico border. Bureau of Transportation Statistics, US Department of Transportation

Total trade with Mexico and Canada has **increased in 2019 by \$1.7 billion, or 8.3%**, since 2015. Total trade with Mexico alone has **increased in 2019 by \$700 million**, or 4.1%, since 2015. US Census Bureau





Eliminating Regulations

Since 2015, Governor Ducey has eliminated 2,289 regulations, saving job creators \$134.3 million.
