As of Day 82 of the session, 1,165 bills posted; 139 passed; 110 signed; 2 vetoed; 118 Memorials or Resolutions posted; 14 passed.

# Demographic Turning Points for the United States: Population Projection for 2020 to 2060

The United States Census Bureau has released a report detailing population projections for 2020 to 2060. This report summaries results from the U.S. Census Bureau's 2017 National Population Projections. Beginning in 2030, all baby boomers will be older than 65, and one in every five Americans is projected to be retirement age. By 2035, it is projected that older adults will outnumber children for the first time in U.S. history. The focus of this report is on 2030 as a demographic turning point for the United States, but the report also explores broader changes in the age, race, and ethnic composition of the population from 2020 to 2060.
